RAFFLESEDUCATION CORP POSTS REVENUE OF \$\$29.1 MILLION FOR FY2015 Q1

- Revenue of S\$29.1 million

Singapore, 13 November 2014 - Raffles Education Corporation Limited ("RafflesEducation *Corp*" or "the Group"), a premier private education provider, announced today that the Group posted revenue of S\$29.1 million, a net profit of S\$0.46 million and EBITDA of S\$6.6 million for the first quarter ended 30 September 2014 ("FY2015 Q1").

Revenue for FY2015 Q1 decreased 5% from S\$30.7 million in FY2014 to S\$29.1 million as the Group ceased consolidating the operational results of Langfang Oriental Institute of Technology ("LOIT") in FY2015 Q1. LOIT contributed S\$1.6 million revenue in FY2014 Q1. Excluding the above S\$1.6 million revenue from LOIT for FY2014 Q1, the revenue for FY2015 Q1 is comparable to FY2014 Q1.

Mr Chew Hua Seng, Chairman and CEO of RafflesEducation *Corp*, said, "Overall, we are seeing our revenue improving in the People's Republic of China (PRC) and our expansion strategy outside of the PRC is yielding positive outcomes. The Group also continues to look at opportunities in other education related investments to achieve sustainable growth."
