Excluding S\$1.6 million revenue from LOIT for FY2014 Q2, the revenue for FY2015 Q2 increased by S\$0.9 million which is about 3% over FY2014 Q2.

Mr Chew Hua Seng, Chairman and CEO of RafflesEducationCorp, said, "The Group is seeing its overall operations improving. We are glad that our subsidiary, Oriental University City Holdings (H.K.) Limited, has been listed on the Growth Enterprise Market of The Hong Kong Stock Exchange successfully. The Group's expansion strategy outside of the PRC is yielding positive outcomes and will continue to look at opportunities in other education related investments to achieve sustainable growth."
